



WAIVER AND RELEASE OF LIABILITY FOR MINORS
READ BEFORE REGISTERING

Every individual who will participate in pickleball games, activities, and events (a "Participant") at Prestige Pickleball Club and Premier Pickleball (the "Club") must sign this Waiver and Release of Liability (this "Release").

In consideration of being allowed to participate in the aforementioned activities at the Club, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, I, on behalf of myself and my successors, heirs, and assigns, hereby irrevocably and unconditionally agree with and represent to the Club as follows:

I have reached the legal age of majority in my jurisdiction of residence and have every right to contract in my own name, or as the parent or guardian of minor children (a "Minor Participant"), and execute this Release.

I acknowledge and understand that any athletic or physical activity involves certain risks and dangers of accidents, injuries, losses and/or damages to person or property, including but not limited to, the potential for exposure to and illness from infectious diseases, personal and bodily injuries of any kind, permanent paralysis, and death, that may be sustained by, or in connection with the use of the Club facilities and/or the participation in the activities, and I understand, have considered and have evaluated the nature, scope and extent of the risks involved, and I voluntarily and freely choose to assume these risks.

I, on behalf of myself, and my heirs, assigns, personal representative and next of kin, hereby fully and forever release, hold the Club harmless, and discharge and absolve the Club, and its officers, directors, officials, managers, agents, owners, employees, property owners, principals, other Participants from any and all liability or responsibility including when such illness, accident, or injury is caused by the active or passive negligence of the Club, its officers, directors, officials, managers, agents, owners, employees, property owners, principals, other Participants, and its principals, all of which liability and responsibility I knowingly and deliberately assume.

I willingly agree to comply with the stated and customary terms and conditions for participation in activities at the Club. If, however, I observe any unusual significant hazard during my presence or participation in Club activities, I will cease any such activity and immediately bring such unusual significant hazard to the attention of the nearest Club official.

I, on behalf of myself, or on behalf of a Minor Participant, do hereby irrevocably consent and give my permission to the Club, its affiliates, officers, directors, officials, managers, agents, owners, employees, principals, as well as any third party which the Club determines in its sole discretion to be appropriate, a royalty free, irrevocable right and license, to use, exploit, adapt, modify, sell, sublicense, reproduce, record, photograph, digitize, distribute, publicly display, publicly perform, and create derivative works, throughout the world in any and all forms whether now known or later developed, my, or the Minor Participant's, image, name, voice, likeness, or persona in any and all commercial exploits or ventures, promotional materials or announcements, publications, media releases, or advertisements, electronic or otherwise in any medium now known or hereafter developed ("Work(s)"), in perpetuity, and waive any and all rights to the same. I acknowledge and agree that I will not receive any compensation whatsoever if my, or the Minor Participant's, image, name, voice, or likeness appears in any Works, or from any proceeds of any utilized Work. I acknowledge and agree that any use of my, or the Minor Participant's, image, name, voice, likeness, persona, or resulting Work is solely the property of the Club in perpetuity. In addition, I acknowledge and agree that the Club may, without my permission or advance notice to me, supply my, or the Minor Participant's, image, name, voice, likeness, persona, or resulting Work to any third party which the Club determines in its sole discretion to be appropriate, for any use, publication, and/or offer of information, programs, and/or services.

I HAVE READ THIS RELEASE CAREFULLY. I FULLY UNDERSTAND ITS TERMS AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY CONTINUING WITH THE REGISTRATION PROCESS FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
